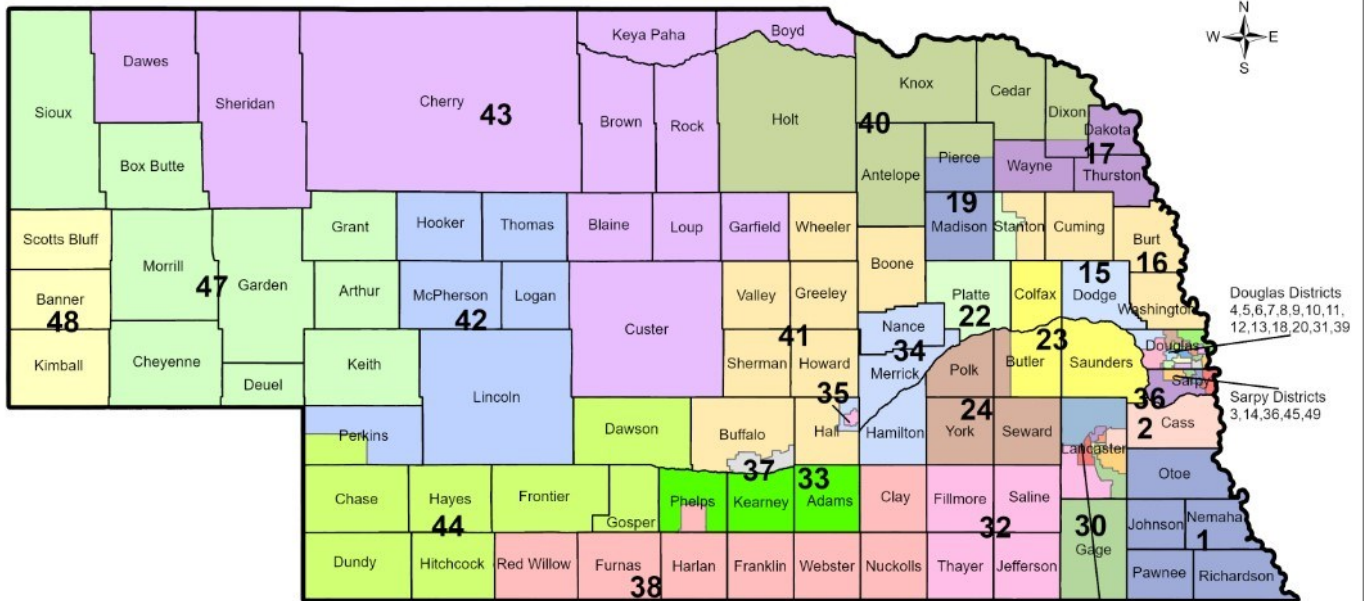
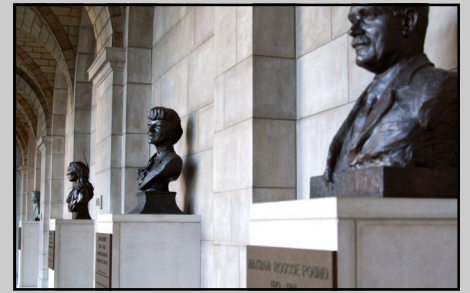

## 2024 Candidate Overview



This year there are 25 State Legislative seats up for election. There are 13 open seats due to term-limits. One incumbent senator is not seeking re-election and one appointed senator is not seeking election. Ten senators are running for election, three of those were appointed within the last two years due to vacated seats.

### Nebraska Legislature Facts

- One house legislature called a Unicameral (only one in the U.S.)
- 49 State Senators
- 4-year terms
- Term-limits: two, four-year consecutive terms
- Non-partisan elections
- 1/2 of the seats are up for election every second year
- Filing fee to become a candidate is \$120
- Salary: \$12,000 annually (unchanged since 1988) plus per diem
- Legislative session lasts 60 days in even-numbered years and 90 days in odd-numbered years (convenes on the first Wednesday following the first Monday in January each year)

- May 6—Second Primary campaign statement due
- June 24—Post Primary campaign statement due
- October 7—First General campaign statement due
- October 28—Second General campaign statement due
